Notice is hereby given that the Metropolitan District of Limerick, proposes to introduce Bye-Laws under Section 199 of the Local Government Act. 2001 (as amended) to manage and control the operation of Dockless On-Street Bicycle Hire Operations in Limerick City and Environs. The Council has now drawn up Draft Bye-Laws to regulate such operations in Limerick City and Environs.

The Draft Bye-Laws cover the issuing of Operators' licences, and provide for a permit fee for each individual bicycle, in addition to specifying certain minimum standards for operators and bicycles, together with the ability for the Council to prescribe streets/areas where Dockless On-Street Hire Bicycles should or should not be deployed.
