##### LANDSCAPING FILL AREA AT BALLYGRENNAN; LIMERICK FOR DISPOSAL OF UNCONTAMINATED INERT SOIL AND STONE MATERIAL FROM COONAGH KNOCKALISHEEN DISTRIBUTOR ROAD

In accordance with Part XI of the Planning & Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Limerick City and County Council proposes to carry out the following development:-

**Landscaping Fill Area on lands in the townland of Ballygrennan; Limerick for disposal of uncontaminated inert soil and stone material from Coonagh Knockalisheen Distributor Road.**

- The proposed development comprises:-
- The reuse of uncontaminated inert soil and stone material excavated as part of the Coonagh Knockalisheen Distributor Road project as landscape fill on lands bounding the scheme. The proposed finished ground levels of the proposed development will help to integrate the road embankment into the surrounding landscape at Ballygrennan.
- The overall landscape fill volume comprising of the excavated soil and stone is 26,000m<sup>3</sup> within the original Compulsory Purchase Order boundary and 39,000m<sup>3</sup> on lands outside the Compulsory Purchase Order. This is equivalent to approximately 47,000 tonnes within the original Compulsory Purchase Order boundary and approximately 72,000 tonnes outside the Compulsory Purchase Order.

Limerick City & County Council has carried out an Environmental Impact Assessment (EIA) Screening Report in accordance with the requirements of Article 120(1B)(i) and (ii) and the requirements of Article 120(1B)(i) and (ii) has determined that there is no real likelihood of significant effects on the environment. Accordingly, it has been determined that EIA is not required in respect of this proposed development. Nonetheless, a person may within 4 weeks from the date of the notice, apply to An Bord Pleanála for a screening determination.

Limerick City & County Council has carried out an Appropriate Assessment (AA) Screening Report and has determined that a full Appropriate Assessment is not required in respect of this proposed development.

##### N20 BANOGUE TRAFFIC CALMING SCHEME

In accordance with Part XI of the Planning & Development Act 2000 (as amended) and Part 8 Article 81 of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Limerick City & County Council proposes to install traffic calming on the N20 National Primary Road at Banogue Cross. The works will be located in the townlands of Ballyabanogue and Ballyphilip.

**Nature and extent of the proposed development is as follows:-**

- The proposed improvement works will be carried out within the existing 60km/h speed limit zone over a distance of 410m, 185m of which is north of Banogue Cross with 225m to the south of Banogue Cross and will provide for:-
- The installation of gateway signage and narrower carriageway lanes bounded by kerbing, footpaths and landscaping
- The installation of traffic calming signage on the approach to Banogue Cross
- A controlled pedestrian crossing in the vicinity of Dillon's Maxol service station
- Surface water drainage
- Public lighting
- Signage, road markings
- Accommodation works and associated site works

Limerick City & County Council has carried out an Appropriate Assessment (AA) Screening Report and has determined that a full Appropriate Assessment is not required in respect of this proposed development.

In accordance with Part XI of the Planning & Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Limerick City & County Council proposes to build an Urban Greenway (cycling and walking) providing connectivity between Castletroy College and Gaelscoil Chialadh an Treigh. The works will be located in the townlands of Newtown and Newcastle, Castletroy, Limerick.

The proposed improvement works will consist of a new 3.5m wide cycleway alongside a new 2.5m wide footpath, enclosed by 1m grass verges, with the main spine extending for approx. 820m linking Castletroy College Road with the access road to Gaelscoil Chialadh an Treigh. Secondary spines will link to future residential development to the east (approx. 170m in length) and Castletroy Shopping Centre (Town Centre) to the west (approx. 260m). Appropriate access points to the Greenway will be provided along its length. The proposed works also include for the installation of LED public lighting, security fencing where appropriate, tree and shrub planting areas as well as surface water drainage. Accommodation works will be undertaken as required including improvement works and car park alterations as necessitated for Gaelscoil Chialadh an Treigh.

In accordance with S.I. 476, 2011, Section 250, Planning and Development (Amendment) (No. 3) Regulations, 2011, Limerick City & County Council has carried out an Appropriate Assessment Screening report and it has been determined that an Appropriate Assessment is not required.

In accordance with Part XI of the Planning & Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Limerick City & County Council proposes to build a new canal bridge to provide two-way traffic flow between Canal Bank, Park Road and Lower Park Road, Limerick.

The proposed development will consist of a new bridge crossing of the canal to be constructed to the east of the current Park Road Bridge. This new bridge will connect Lower Park Road with Canal Bank, Park Road, facilitating two-way traffic flow. Vehicle traffic on South Canal Road will change from the current one-way system to a two-way system with the carriageway being widened accordingly. The existing Park Road Bridge will be retained as a pedestrian and cycle facility only with the existing traffic lights at this location being removed. The proposed works also include for: new road surfacing, installation of LED public lighting & surface water drainage, and demolition of an existing out building on the corner of Park Road and Canal Bank with accommodation works as required.
