Notice of Application to An Bord Pleanala for Approval

The proposed works at Ballinloughane Bridge, Athea, Co Limerick comprise of a reinforced concrete and steel beam slab (jack-arch) supported on mass concrete abutment walls. The proposed works involves the removal of the bridge deck and its replacement with a precast concrete bridge beam and in-situ concrete deck construction. The abutments will be retained in position and used to support new concrete bench seating's for the bridge beams.

Pursuant to section 177AE of the Planning and Development Act 2000 (as amended) and the requirements of the Planning and Development Regulations 2001 (as amended), notice is hereby given that Limerick City and County Council proposes to make an application for approval to an Bord Pleanala for the following development: **Ballinloughane Bridge, Athea, Co Limerick**

A Natura Impact Statement (NIS) has been prepared in respect of the proposed development.

The Board may, in relation to an application for approval under section 177AE, of the Planning and Development Act 2000, as amended, may give approval to the application for development with or without conditions or may refuse the application for development.

The bridge is located on a third order stream; one of the two headwater streams which make up the Galey River, both known as the Galey River. The bridge site is surrounded by commercial non-native forestry plantations, scrub, wet grassland and improved agricultural grassland and bog habitats in the upper reaches of the catchment.
