## **ANNING AND DEVELOPMENT ACT 2000** (AS AMENDED) NOTICE OF PROPOSED AMENDMENT NO. 1 TO THE KILMALLOCK **LOCAL AREA PLAN 2019 - 2025**

Pursuant to Section 20 of the Planning and De elopment Act 2000 (as amended) notice is hereby given that Limerick City and County Council being the Planning Authority for the area, proposes to make an amendment to the Kilmallock Local Area Plan 2019-2025.

The proposed amendment comprises of a change in zoning of a site within the settlement from "Residential Development Area" to "Enter and Employment". This change of zoning requires an amendment in "Enterprise both the written statement and maps and is accompanied by a Strategic Environmental Assessment Screening Report, Appropriate Assessment Screening Report and associated determinations.
