Notice is hereby given that, pursuant to Section 38 (3) of the Road Traffic Act 1994, as amended by the Public Transportation Regulation Act, 2009 (Section 46), Limerick City & County Council hereby gives notice of its intention to introduce the following road layout amendments on the L-8650, at Knockainey National School, Knockainey, Co. Limerick.

- Install new Zebra Crossing
- Install new Road Markings
 Install New Tactile Paving
- Extension of existing public footpath opposite Knockainey National School
- Junction tightening where L8650 meets L8651 above Knockainey National School

The works will involve the construction and installation of a Zebra Crossing, extension of existing footpath, new kerb line, road markings, tactile paving and associated works.
