Notice is hereby given, pursuant to Section 12(1)(b) of the Planning and Development Act, 2000 (as amended) that Limerick City and County Council being the Planning Authority for Limerick, has prepared a Draft Development Plan for the administrative area of Limerick. The Draft Plan is the first consolidated Draft Plan prepared for Limerick City and County and will replace both the Limerick City Development Plan 2010 – 2016 (as extended) and the Limerick County Development Plan 2010 – 2016 (as extended), when adopted.

The Draft Limerick Development Plan is set out in 6 volumes as follows:

- Volume 1 – Written Statement;
- Volume 2 – Settlement and Zoning Maps;
- Volume 3 – Architectural Conservation Areas and Record of Protected Structures;
- Volume 4 – Environmental Reports, including Strategic Environmental Assessment, Natura Impact Statement and Strategic Flood Risk Assessment;
- Volume 5 – Special Areas of Conservation, Special Protection Areas, Natural Heritage Areas, Proposed Natural Heritage Areas and Record of Monuments and Places;
- Volume 6 – Draft Retail Strategy for Limerick – Shannon Metropolitan Area and County Limerick, Review and Update of the Limerick 2030 – An Economic and Spatial Plan for Limerick, Limerick City and County Draft Housing Strategy and Housing Needs Demand Assessment, Draft Limerick Building Height Strategy and Strategic Integrated Framework Plan for the Shannon Estuary.
