## PLANNING & DEVELOPMENT ACTS 2000 (AS AMENDED) PLANNING & DEVELOPMENT REGULATIONS 2001 (AS AMENDED) PART 8 DEVELOPMENT

In accordance with Part XI of the Planning & Development Acts 2000 (as amended) and Part 8, Article 81 of the Planning and Development Regulations 2001 (as amended), notice is hereby given that **Limerick City** & County Council proposes to carry out the development described hereunder at the following site at **Broadford**, County Limerick.

The proposed development will be completed in two phases and will consist of:

- (i) Phase 1: The provision of 11 no. residential units, consisting of, 2 No. 1 Bed units, 1 No. 4 Bed unit, 6 No. 2 Bed units, 2 No. 3 Bed units,
- (ii) Phase 2: The provision of 7 no. residential units, consisting of, 5 No. 1 Bed units, 2 No. 2 Bed units.
- (iii) Hard landscaping including new footpaths, new entranceways, boundary treatments and boundary walls,
- (iii) Upgrading of foul sewers and surface water drainage, and (iv) All associated site works.

Limerick City & County Council has carried out an Environmental Impact Assessment (EIA) Screening Report in accordance with the Roads Act 1993 (S.I. No 14 of 1993), as amended and has determined that there is no real likelihood of significant effects on the environment. Accordingly, it has been determined that an EIA is not required in respect of this proposed development. Nonetheless, any person may within 4 weeks from the date of this notice apply to An Bord Pleanåla for a screening determination.

Limerick City & County Council has carried out an Appropriate Assessment (AA) Screening Report and it has been determined that a full Appropriate Assessment is not required in respect of this proposed development.

Plans and particulars of the proposed development will be available for inspection and/or purchase at a fee not exceeding the reasonable cost of making a copy from the 06th December 2021 up to and including the 12th January 2022 at the Customer Services Desk, Limerick City & County Council, Merchant's Quay, Limerick, V94 EH90 and at the Planning and Environmental Services Department, Limerick City & County Council Offices, Dooradoyle Road, Limerick, V94 WV78 between 9 a.m. - 4 p.m. Monday to Friday (excluding Bank Holidays).
