**Proposed works  
Dublin Road (R-445) and Park Road (L-10171), Limerick City**

Notice is hereby given that, pursuant to Section 38 (3) of the Road Traffic Act 1994, as amended by the Public Transportation Regulation Act, 2009 (Section 46), Limerick City & County Council hereby gives notice of its intention to introduce the following road amendments on R-445 Dublin Road, Limerick City and L-10171 Park Road, Limerick City.

- Install new pedestrian crossing on Park Road.
- Install new road markings for "School Zone" on Dublin Road and Park Road.
- Install new relevant tactile paving at new pedestrian crossings.
- Relocate and narrowing Pedestrian crossing on Dublin Road.
- 2hr Pay and Display parking in front of Singland Court and Clare St. Terrace
- Introduction of bus cages in-lane.
- Installation of planters and pencil bollards adjacent to school
